First Meeting of Defence Ministers of E3 Countries

Federal Minister of Defence Annegret Kramp-Karrenbauer will invite her colleagues, Florence Parly of France and Ben Wallace of the United Kingdom, to the first formal meeting of Defence Ministers of the E3 group in Saarland on 20 and 21 August 2020.

Press is invited for the statement after the trilateral defence ministers talk in close-by Dillingen/Saar.

Please note that in line with COVID-19 protective measures and the hygiene concept in place for the two events, a maximum of 30 spots can be allocated to media representatives.

You will receive confirmation of your spot.

Several representatives from one medium can receive accreditation. However, only one representative per medium carrying a press badge will be allowed at the event at any given time. The exact procedure will be outlined when you receive confirmation of your spot.

Accredited media representatives are required to follow the applicable physical distancing and hygiene rules and wear face coverings. Some stocks of face masks will be made available to accredited media representatives.

Privacy Policy

1. Consent

- a) The disclosure of your personal data is voluntary. You are under no legal or contractual obligation to disclose personal data.
- b) Failure to give consent will result in your exclusion from participation in the event.

2. Withdrawal of consent

In accordance with Article 7(3) of the EU General Data Protection Regulation (GDPR) you have the right to withdraw consent at any time with regard to the future. This will not affect the lawfulness of processing carried out before consent was withdrawn.

3. Processing

- a) The legal basis of data processing is consent given in accordance with Article 6(1)(a) in conjunction with Article 7 GDPR.
- b) Data is collected for the purpose of ensuring your participation in the event and is transferred to the responsible police authorities for a security check.
- c) The data will be saved in an EXCEL file.
- d) There will be no automated decision-making (Article 22 GDPR).
